## Statement of intent

<p><b>Principles</b></p> <ul style="list-style-type: none"><li>• We ensure that teaching and learning opportunities meet the needs of all of the pupils</li><li>• We ensure that appropriate provision is made for pupils who belong to vulnerable groups, this includes ensuring that the needs of socially disadvantaged pupils are adequately assessed and addressed</li><li>• In making provision for socially disadvantaged pupils, we recognise that not all pupils who receive free school meals will be socially disadvantaged</li><li>• We also recognise that not all pupils who are socially disadvantaged are registered or qualify for free school meals.</li><li>• When allocating Pupil Premium funding which benefits groups of pupils, the groups may include in addition to those who qualify for the Premium, a minority of pupils that the school has legitimately identified as being socially disadvantaged.</li><li>• Pupil Premium funding will be allocated following a needs analysis which will identify priority classes, groups or individuals.</li></ul>
<p><b>Provision</b></p> <ul style="list-style-type: none"><li>• The range of provision the Governors may consider making for this group could include:<ul style="list-style-type: none"><li>▪ Reducing class sizes thus improving opportunities for effective Assessment for Learning and accelerating progress</li><li>▪ Providing small group work with an experienced member of staff focussed on overcoming gaps in learning</li><li>▪ One-to-one, Two-to-one and small group tuition</li><li>▪ Additional teaching and learning opportunities provided through learning mentors, trained TAs or external agencies</li><li>▪ Other measures which promote inclusion and support access to the wider curriculum, including development programmes e.g. “Gifted and Talented” (sport, music etc)</li></ul></li><li>• All our work through the Pupil Premium will be aimed at accelerating progress moving children to at least age related expectations. Initially this will be in reading, writing and maths</li><li>• Pupil Premium resources may also be used to target more able children on Free School Meals to achieve a higher standard so that expected progress is achieved.</li></ul>
